##### **Article 1 APPOINTMENT**

###### **110.1.1 By-law Enforcement Officers**

The persons whose names and designations appear in Schedule 'A' of this Chapter are hereby appointed as By-law Enforcement Officers for the City of Kitchener. By-law 88-167, 22 August, 1988.

##### **Article 2 DUTIES - AUTHORITY**

###### **110.2.1 Duties - conferred**

Each such By-law Enforcement Officer:

- (a) shall be a Provincial Offences Officer for the City;
- (b) shall work under the direction of the Director of Enforcement;
